WSIS+10: Stakeholders map the Internet's future and endorse progress made

Throughout 2015 the United Nations General Assembly (UNGA) reviewed the progress made in achieving the goals set out 10 years ago at the World Summit on the Information Society (WSIS) meeting in Tunis, which set targets for the international community to ensure an inclusive information society. Speaking at the high-level event at the UNGA in New York ICC Secretary General John Danilovich applauded the conclusion of the agreed outcome document that endorses the global multistakeholder community's collective management of the Internet and extends the mandate of the Internet Governance Forum (IGF) for another 10 years.
